#### **SECTION 4**

#### FIRST AID MEASURES

#### 4.1. DESCRIPTION OF FIRST AID MEASURES

#### INHALATION

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. ### 7.1. PRECAUTIONS FOR SAFE HANDLING
