#### **NOTIFICATION PROCEDURES**

In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.

#### **PROTECTIVE MEASURES**

Avoid contact with spilled material. See Section 5 for fire fighting information. See the Hazard Identification Section for Significant Hazards. See Section 4 for First Aid Advice. For emergency responders: Respiratory protection: respiratory protection will be necessary only in special cases, e.g., formation of mists.
